Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

How?	All financial companies need to share personal information to run their everyday business. In the section below, we list the reasons financial companies can share their personal information; the reasons World Famous Autos chooses to share; and whether you can limit this sharing.

How does World Famous Autos protect my personal information?

These measures include computer safeguards and secured files and buildings. Our data is hosted by a cloud DMS company that employs stringent security to ensure our data is protected. All written information is locked.

How does World Famous Autos collect my personal information?

We collect your personal information, for example, when you

- Submit an Application or Credit Card Payment
- Purchase a Vehicle or Establish a Loan
- Provide information over the phone or electronically

Why can't I limit all sharing?

Federal law gives you the right to limit only

- sharing for affiliates' everyday business purposes—information about your creditworthiness
- affiliates from using your information to market to you
- sharing for nonaffiliates to market to you

State laws and individual companies may give you additional rights to limit sharing.

Affiliates

Companies related by common ownership or control. They can be financial and nonfinancial companies.

Companies not related by common ownership or control. They can be financial and nonfinancial companies.

Joint marketing
